FAQ:

What specific qualifications or prerequisites are needed for participants before enrolling in the course?

While there are no formal prerequisites, it is recommended that learners have a foundational understanding of occupational safety and health. Prior NEBOSH General Certificate is a plus but not mandatory.

How long is each day's session, and is there a total number of hours required for the entire course?

Each day's session is generally structured to last around 4-5 hours, with breaks and interactive activities included. The total course duration spans five days, approximately 20-25 hours of instruction.

What is the FARSI model and how is it applied in safety-critical systems?

The FARSI model Functionality, Availability, Reliability, Survivability, Interdependency helps evaluate and maintain the integrity of safety-critical systems and equipment, particularly in preventing catastrophic process failures.

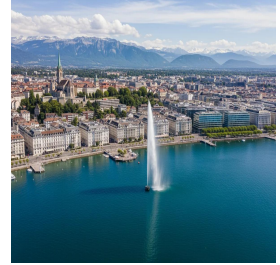
