## Course Overview:

The ISO 55001 Lead Implementer Training Course provides participants with the knowledge and implementation skills required to establish, operate, maintain, evaluate, and continually improve an Asset Management System AMS based on ISO 55001:2024.

The course examines how organizations can align asset management activities with corporate strategy, stakeholder expectations, operational priorities, financial objectives, sustainability requirements, and risk management principles. Participants learn how to initiate an AMS implementation project, define its scope, establish governance responsibilities, develop an asset management policy, and prepare a Strategic Asset Management Plan SAMP.

The course also addresses asset management decision-making, asset life cycle planning, information and knowledge management, operational controls, outsourcing, change management, performance evaluation, internal auditing, management review, corrective action, predictive action, and certification audit preparation.

Aligned with the current PECB ISO 55001 Lead Implementer course structure, the programme covers the seven examination competency domains and follows the official five-day sequence: initiation, planning, implementation, performance evaluation, continual improvement, certification preparation, and examination.

## Course Objectives:

By the end of this ISO 55001 Lead Implementer course, participants will be able to:

- Explain the principles, concepts, terminology, and benefits of asset management.
- Interpret ISO 55001:2024 requirements from an implementer's perspective.
- Establish the business case and governance structure for an AMS implementation.
- Analyse organizational context and relevant stakeholder requirements.
- Determine the scope and boundaries of the Asset Management System.
- Develop an asset management policy, objectives, and Strategic Asset Management Plan.
- Establish risk-based and value-based asset management decision-making criteria.
- Implement life cycle management, operational controls, and supporting processes.
- Evaluate AMS performance through indicators, audits, and management reviews.
- Manage nonconformities, corrective actions, predictive actions, and continual improvement.
- Prepare an organization for an ISO 55001 certification audit.
- Address the seven competency domains of the Lead Implementer examination.

## Training Methodology:

The training combines structured presentations, clause-by-clause interpretation, guided discussions, practical implementation examples, scenario-based exercises, and examination-oriented review questions.

Participants examine how organizational objectives are translated into asset management objectives, decision criteria, the Strategic Asset Management Plan, and operational asset management plans. Practical activities address stakeholder analysis, AMS scoping, governance responsibilities, risk and opportunity evaluation, asset life cycle controls, performance indicators, internal audits, management reviews, corrective actions, and certification readiness.

The methodology emphasizes the role of the Lead Implementer in coordinating implementation activities across engineering, maintenance, operations, finance, risk, procurement, information management, and senior leadership.

Participants will also consider the enhanced requirements and emphasis of ISO 55001:2024, including asset management decision-making, organizational knowledge, value realization, and predictive action.

## FAQ:

What specific qualifications or prerequisites are needed for participants before enrolling in the course?

Participants should have a basic understanding of asset management principles and concepts. Experience in maintenance, engineering, operations, facilities, risk management, finance, or management systems will help participants apply the implementation requirements more effectively. No formal certification is required merely to attend the course.

How long is each day's session, and is there a total number of hours required for the entire course?

Each day's session is generally structured to last around 4-5 hours, with breaks and interactive activities included. The total course duration spans five days, approximately 20-25 hours of instruction.

## What is the difference between an asset management plan and a Strategic Asset Management Plan?

The Strategic Asset Management Plan establishes the high-level relationship between organizational objectives and asset management objectives. It defines the organization's strategic direction, decision criteria, priorities, governance arrangements, and approach to achieving value from assets.

Individual asset management plans translate this strategic direction into specific activities, responsibilities, resources, schedules, operating controls, maintenance programmes, renewal decisions, and performance indicators for particular asset portfolios or asset groups.

## How This Course Is Different from Other ISO 55001 Lead Implementer Courses:

This ISO 55001 Lead Implementer course goes beyond a general explanation of the standard by guiding participants through the complete practical architecture of an Asset Management System. The content follows the current PECB five-day course sequence and addresses all seven Lead Implementer examination domains while maintaining a strong workplace implementation focus.

Participants examine how to connect corporate objectives with asset management policy, strategic planning, investment decisions, operational priorities, risk controls, asset information, and measurable performance. Particular attention is given to the Strategic Asset Management Plan, asset management decision-making, life cycle value, stakeholder requirements, organizational knowledge, predictive action, and certification readiness.

The course also reflects significant themes emphasized in ISO 55001:2024, including structured decision-making, value realization, knowledge management, risk and opportunity effectiveness, and proactive intervention based on asset condition and performance information. Rather than treating ISO 55001 as an isolated compliance framework, the programme demonstrates how engineering, maintenance, operations, finance, procurement, risk, information management, and leadership must work together to implement an effective AMS.

Participants leave with a clear implementation pathway and practical tools that can be adapted to their organization's assets, scale, operational environment, and strategic priorities.
